- INSTRUCTIONS: 1. All candidates for County office must file both declarations with the County Registrar-Recorder/County Clerk. They may be filed at any time, but no later than the close of nomination document filing for the primary election and 30 days after the primary for the general election.
 - 2. Each candidate choosing Category 2, Category 3 or Category 4 of the Contribution of Personal Funds Declaration must actually deposit an amount of personal funds at least equal to the applicable Category minimum in his or her campaign fund within 10 days of filing the Contribution of Personal Funds Declaration, and file a Form 808, Deposit of Personal Funds Declaration, within 24 hours hereafter.
